  - the adequacy, reliability and accuracy of financial reporting and information;
  - performance management;
  - effective governance;
  - compliance with the Municipal Finance Management Act, and all applicable Municipal legislation;
  - performance evaluation; and
  - any other issues referred to it by the Municipality.
- Review the annual financial statements of the Municipality, to provide the Council with an authoritative and credible view of the financial position of the Municipality, and its overall compliance with Municipal Legislation;
- Respond to the Council on any issues raised by the Auditor-General;

- Carry out such investigations into the financial affairs of the Municipality as may be requested;
- Perform such other functions as may be prescribed.

The appointment of each Audit and Performance Committee member will be supported by written terms of reference and a contract for three (3) years.
